- 2. ID proof original (Ex. PAN Card/ Voter ID/Driving License) should be shown at the time of speed test.
- 3. A Photocopy of your photo identity card should be submitted on the day of the speed test on computer.
- 4. Candidates are requested to bring the following documents with you positively at the time of speed test on computer:
 - a) All testimonials / Certificates in original and attested copies. Candidates who fail to bring the original certificate for Speed Test/Interview will not be considered.
 - b) Caste certificate in original along with attested copies in support of age relaxation.
 - c) No Objection Certificate from the present employers (for Govt/PSU servants only).
- 5. The candidates are required to bring this admit card with a recent passport size photograph affixed in the space provided, failing which, the candidate will not be allowed to appear in the speed test.
- 6. A Merit List of the candidates will be prepared based on their marks obtained in the speed test. The eligible candidates in the speed test on computer will be allowed to attend the interview on 26th April 2017 at 12:00 Noon.
- 7. Mere appearance/ passing the Speed Test / Interview doesn't give any right to the candidates for appointment at NCDIR.
- 8. Canvassing in any form will disqualify the candidates.
- 9. In the event of any information being found false or incorrect at any stage, the candidature/appointment is liable to be cancelled/terminated.
