2. The Educational Qualifications prescribed for Junior Translator (CSOLs) as on 01.08.2013 are as under:-

ESSENTIAL:

(I)

- (a) Master's Degree of a recognized University or equivalent in Hindi or English with English or Hindi as a compulsory or elective subject or as a medium of examination at degree level **OR**
- (b) Master's Degree of a recognized University or equivalent in any subject other than Hindi or English with Hindi or English medium and English or Hindi as a compulsory or elective subject or as a medium of examination at degree level **OR**
- (c) Master's Degree of a recognized University or equivalent in any subject other than Hindi or English with Hindi and English as a compulsory or elective subject or either of the two as medium of examination and the other as a compulsory or elective subject at degree level;

AND

(II) Recognized Diploma or Certificate Course in Translation from Hindi to English and vice-versa OR Two years' experience of translation work from Hindi to English and vice-versa in Central or State Government Offices including Government of India Undertakings.

DESIRABLE:

- (i) Knowledge at the level of Matriculation of a recognized Board or equivalent of one of the languages other than Hindi mentioned in the Eighth Schedule of the Constitution
- (ii) Degree or Diploma in translation from Hindi to English and vice-versa from a recognized University.
- 3. You should bring Certificates in support of your Date of Birth (DOB), Educational Qualification (EQ), Community Certificate (if applicable) and other relevant Certificates as mentioned in the Annexure, in Original and submit 2 set of self-attested copies of the documents/certificates for our record.
- 4. It may be noted that candidates not possessing Certificates in support of DOB, EQ etc. will not be allowed for the Interview.
