- Printout of the online application submitted to IBPS for CWE Clerks-VI
- Date of birth proof certificate (Date of Birth Certificate or 10<sup>th</sup> /SSC/SSLC Certificate with Date of Birth)
- Marks Cards & Certificates of Class XII/PUC/Diploma etc.
- Year-wise/Semester-wise marks sheets and Certificates (Provisional Degree Certificate or Final Degree Convocation) of Graduation issued by **University** in support of their eligibility.
- Mark sheets and Certificates of Post-Graduation, Professional qualifications, additional qualifications etc., if any.
- Work Experience Certificate/Service Certificates, if any.
- The candidates belonging to SC/ST/OBC/PWD categories must produce a relevant and <u>valid</u>
  Caste/ PWD certificate issued by the competent authority in the prescribed format as notified in the advertisement.
