Candidates must bring the following documents in original along with **duly self attested copies**.

- Proof of date of birth certificate/Matriculation certificate wherein the date of birth of candidate is recorded (failure to present the same shall render the candidature of the candidate as cancelled);
- (ii) In case of claiming age relaxation, Requisite certificate for age relaxation (whichever is applicable) (SC/ST/OBC(Non-Creamy layer)/ Ex-servicemen/ PWD) obtained in the prescribed format from Competent Authority.
- (iii) Standard 10<sup>th</sup> onwards Mark sheet, certificates of academic & professional qualifications, diploma / degrees and statement of marks of all the semesters / years / attempts of examinations of prescribed qualification.
- (iv) Experience certificate if applicable.
- (v) Document proof of pay and allowances etc. drawn in various posts, if employed currently or previously.
- (vi) SC/ST/OBC/PWD certificates as applicable issued by competent authority. Further, OBC candidates are required to submit caste certificate certifying 'non creamy layer' status applicable for service under Government of India, failing which they will not be given benefits under OBC category;
- (vii) Candidates serving in Central/State Government/ Public Sector Undertaking including Public Sector Banks/ Autonomous Bodies etc. are required to produce a "No Objection Certificate" from their employer in original failing which shall render the candidature of the candidate as cancelled.
- (viii) Discharge slip/NOC for Ex-Servicemen from the Competent Authority.
- (ix) Disability certificate in prescribed form issued by Competent Authority in respect of Physically Handicapped Category.
- (x) Call letter for verification.
- (xi) The E-Admit Card issued to the candidates for the Computer Based Examination conducted on 21.01.2017.
- (xii) Photo copy of acknowledgement slip of the online examination.
- (xiii) Total marks obtained / score card of the online examination.
- (xiv) Five Passport Size Photographs.
- (xv) Original certificates with regard to Educational Qualifications and Technical Qualifications awarded from recognized Institute / University along with one set of photocopies duly self attested to be brought. If any University has awarded grades , then applicant should provide percentage conversion formula from the Institute in original.
- (xvi) Original Fee challan (Loss of original fees challan shall be the sole responsibility of the candidate).

#### General Instructions for the candidates :-

- (a) The candidate must bring the following for document verification failing which shall render the candidature of the candidate as cancelled. Only those candidates who will be meeting the minimum educational eligibility criteria as per aforesaid advertisement will be allowed to appear for document verification.
  - No additional time will be given and the candidature for not producing their original Certificate/testimonials on the date of verification is liable to be cancelled.

- (b) NPCC will not entertain any request for change of date and time schedule of document verification.
- (c) In case, the document verification could not be completed on the specified date and time, it will be rescheduled on the next available date at the same time and venue. You are requested to come prepared accordingly. No hotel charges and other incidental expenses incurred, if any, will be reimbursed.
- (d) No travelling Allowance will be paid to the candidates for attending the document verification. However, out stationed SC/ST candidates found eligible will be paid second class sleeper rail / bus fare by shortest route from Railway Station / Bus Station nearest to their home/place of residence or from where they should actually perform the journey to the place of document verification and back to the same station provided the first 30 km. for both ways are borne by the candidates himself/herself. However, reimbursement will be restricted to the fare in respect of the balance distance only, which should be exceeding 30 km. both for onward and return Journey i.e. excluding NCR.
- (e) The candidature is "purely provisional" subject to subsequent verification of original documents and also fulfilling the eligibility conditions as advertised.
- (f) The candidates are advised to make necessary arrangements for their travel/stay well in advance, so as to reach the specified venue on time.
- (g) The candidates shall ascertain themselves before proceeding for document verification that they are meeting all the eligibility criteria/conditions as stipulated in the advertisement. Candidates, who do not satisfy the eligibility conditions, will be liable to be disqualified at any stage of recruitment/selection.
- (h) If any of the particulars stated by candidates in the application on verification is found to be incomplete or incorrect, or if they are found to have willfully suppressed any material fact/information relevant to the consideration of their case without prejudice to any other action that may be taken in consequence thereof, their candidature will be summarily rejected.

Also, a candidate who has been called for document verification on a particular date may have to overstay by not more than one day for which he/she should make arrangements at his/her own expenses.
- (j) NPCC shall be free to reject any application at any stage of the recruitment process, if the candidate is found ineligible for the respective post. The decision of NPCC in all matters regarding eligibility of the candidates at all stages of selection and any other matter relating to recruitment shall be final. No correspondence or enquiries shall be entertained by NPCC, in this behalf.

- (I) Selected candidates will be required to submit a fitness certificate from a Registered Medical Practitioner approved for conducting such medical examination or from a District Civil Surgeon/CMO in the format of NPCC as placed in the appointment letter before they are allowed to join appointment in NPCC.
- (m) Canvassing in any form by OR on behalf of a candidate will be disqualification to the stated post.
