**PROVISIONAL RESULT TO QUALIFY FOR DOCUMENT VERIFICATION AFTER
APTITUDE TEST FOR THE POST OF ASM**


1. Result of written examination of ASM conducted by RRC-Western Railway on 08-01-2017 was declared on 15-02-2017 and Corrigendum dated 08-03-2017 in which 464 candidates qualified for Aptitude Test. Aptitude Test of these 464 candidates was conducted on 20th & 21st March, 2017 at Rail Nikunj-BCT.
2. In terms of Railway Board's instructions, new Merit Order of candidates qualified in Aptitude Test is prepared based on 70% weightage of marks secured in Written examination and 30% weightage of marks secured in Aptitude test following Community wise reservation rules.
3. Accordingly, **58 candidates** qualified for Document verification in **Regular List** and **30 candidates** qualified for document verification in **Additional List**. **Candidates in Additional List are being called for document verification as Standby candidates and they will be considered for empanelment only if there is a shortfall in empanelment or non materialization from the regular list.**
4. List of 88 candidates (Regular + Additional) qualified for document verification is enclosed. In this list, Roll numbers are given vertically in ascending order and not as per merit.
5. Document Verification will be held on **24th & 25th April, 2017 at RRC Office, Parcel Depot, Grant Road, Mumbai**. Call letter for the Document Verification is being sent through Speed Post. In case of non receipt of Call letter, candidates may download duplicate Admit Card from RRC website www.rrc-wr.com 7 days prior to Document Verification.

6. Candidates are advised to bring all original documents (reg. Date of Birth, Educational Qualification, Caste Certificate etc.) along with 2 sets of passports size colour photographs. They are also advised to bring "Relieving Letter" from their respective Unit Incharge to attend Document Verification on the scheduled date.
7. No request for change of date for Document Verification will be entertained. Candidates are advised to be prepared for more than one day stay, if required.
8. While due care has been taken in preparing the result, in case of any inadvertent error/s is noticed at any stage, RRC- Western Railway reserves the right to rectify it at later stage of selection procedure.
9. This is only the provisional result and NOT the FINAL Panel and qualifying for Document Verification does not entitle any candidate to be appointed on the respective post.
10. Final Panel for ASM shall be prepared on the basis of result of Written Examination/Aptitude Test , Document Verification.
11. RRC, Western Railway reserves the right to declare any candidate unsuccessful or delete his/her name from the notified result/panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of RRC at any stage. The decision of RRC in the matter shall be final.
12. RRC will not entertain any individual queries in this regard.
13. For any legal dispute the jurisdiction will be Hon'ble CAT Mumbai/High Court Mumbai.
