- iv. PWD candidates In addition to (i) above, disability certificate in the prescribed format (PWD Form) issued by the Competent Authority and also belonging to any category mentioned in (ii) and (iii) above.
- v. Ex-Servicemen In addition to (i) above, appropriate NOC/release certificate in the prescribed format (Ex-Servicemen Form).
- vi. Candidates serving in Government / Quasi Govt./ Public Sector Undertakings (including Nationalized Banks, Insurance Companies and Financial Institutions) are required to produce a No Objection Certificate from their employer at the time of interview, in the absence of which their candidature will not be considered.
