If Typewriter brought by the candidate develops any snag or fails during the Skill Test then no extra time will be given to them and no alternate arrangement, whatsoever, shall be made by RRB-Ahmedabad.

The date & venue of Skill Test will be advised to the candidates through RRB/Ahmedabad's website and call letters will be issued to the candidates for the same by regd. Post.

The eligible candidates, who do not get call letter for Skill Test, should report to the venue along with necessary documents and colour Photograph to get Duplicate call letter. Candidates without call letter will not be allowed for Skill Test.

Merely calling a candidate for "Skill Test" does not in any way; entitle him/her for an empanelment/appointment in the Railways.
