They are also advised to bring all Original Certificates, Two Conduct Certificates from Gazetted Officers and Two recent Passport size Photographs and Rs.24 (Rupees Twenty Four only) towards Medical Examination Fee. The Engagement will be subject to the following conditions:

1. Engagement of the Candidates will be subject to verification of authenticity of Original certificates.
2. The engagement of the Lab Assistant/Gr.II would be on full time contract basis for a period up to 30.06.2015 or till regularly selected RRB candidates are available whichever is earlier.
4. During contract engagement a consolidated remuneration of Rs.10,970/- per month will be paid.
5. Lab Assistant/Gr.II engaged on Contract basis will not have any claim or right for his/her continuity or regularization/absorption in Railway service.
6. During the validity of the Contracts, the Full-Time Para-Medical category staff or the Railway administration will be at liberty to terminate the contract by giving 15 days notice at any time during the contract without assigning any reasons whatsoever. The Contract shall also be terminated forthwith, if the Full-Time Para-Medical Staff is found to be mentally or physically incapacitated.
7. The detailed instructions with regard to their duties shall be given while on execution of contract agreement with Railway administration.
