- A self-attested photocopy of all aforementioned documents are required for submission to HR department. You all are required to carry **two latest passport size photographs** not more than three (03) months old.
- If any information furnished by you is found incorrect/false, your candidature will be rejected and you will not be eligible for reimbursement of journey tickets.
