The candidate whose names are shortlisted have been provisionally called for the Personal Interview based on the entries made by them in the ONLINE application for the above post subject to fulfilling the Qualification Requirement (QR) and other eligibility criteria including Certificate duly signed by the respective Controlling Officer/Project HRD Officer. If at any stage of the recruitment process including after recruitment or joining, it is detected that information provided by him/her is incorrect/incomplete/false or is not in conformity with the eligibility criteria as mentioned in the QR, or if it is found that he/she has concealed/distorted any material information, his/her candidature/appointment will be cancelled without assigning any reason thereof.
- 2. The list is purely provisional. Interview and final selection is subject to meeting all requirements as laid down in the Employment Notice and verification of all the required documents furnished by the applicant in the ONLINE application. Please note carefully the following guidelines before appearing for interview and documents to be submitted before the DVC Authority.
- 3. While every care has been taken in preparing the list of provisionally eligible candidate, DVC reserves its right to rectify any fact-based inadvertent error or typographical mistake.
- 4. <u>List of Documents to be brought mandatorily at the time of Personal Interview (PI) in ORIGINAL with one set of self-attested photocopies positively:-</u>
 - a) Printout of On-Line Application Form duly signed and with Left Thumb Impression.
 - b) Proof of Date of Birth (Matriculation Certificate/Secondary School Passing Certificate).
 - c) Degree/Provisional Degree Certificates and semester-wise Marks sheets of Class-X, XII, Diploma in Engineering or Degree in Physics & Chemistry or B.E/B.Tech/B.Sc(Engg.) or equivalent & Other documents/certificates of Diploma in Industrial Safety, Viva-Voce test, Written test etc.
 - d) Caste & Disability certificate (In case of OBC-NCL/SC/ST/PWD) in GOI Format. (In case of OBC (NCL), certificate must not be older than 6 months).

- f) Recommendation/Certificate of the Controlling Officer/Project HRD Officer with Signature & Seal as per ANNEXURE-1 (Available in DVC website).
- g) Four recent passport size colored photographs duly self-attested.
- h) Current Pay slip.
- i) DVC Identity Card.
- 5. Mere appearing the name in the short listed list or mere appearing in the Personal Interview does not bestow upon the candidate any right to be selected suo moto to the post applied for.
- 6. If anyone whose name does not appear in the list but had submitted his/her online application meeting the DVC QR and hence eligible, may contact this office with all supporting original documents mentioned under SI. No. 4 along with the Recommendation/Certificate of the Controlling Officer/Project HRD Officer on or before 31st March, 2017 at HR Dept, DVC, DVC Towers, VIP Road, Kolkata-700054 or may email to recruitment@dvc.gov.in on or before 31st March 2017 along with scanned copy of documents for proof of eligibility. However, in such cases onus lies with the candidate to prove his/her eligibility based on documents for the said post.
- 7. Candidates are entitled to get T.A. only for attending Interview from their respective Project/Station of DVC as per rules for which a certificate will be issued from this end.
- 8. If candidates fail to bring all the required documents/certificates in original (as mentioned under SL. No. 4) in support of his/her eligibility, the candidates may not be allowed to appear in Interview and no certificate will be issued for TA purpose.
