  - e) **Degree/Provisional Degree in support of Educational/Professional qualifications [MBBS Degree Certificate-Candidates must ensure that MBBS degree is recognized by Medical Council of India (MCI)].**
  - f) Testimonials & Mark sheets (semester/year wise) of educational & professional qualifications.
  - g) Internship Certificate.
  - h) **Experience Certificate.**
  - i) No Objection Certificate (NOC) from his/her present employer (in case of Govt./Semi-Govt./PSU/Statutory organisation).
  - j) 4(Four) recent passport size colored photographs duly self-attested.
