1. Candidate must bring their Receipt of Token of application which was given at the time of receiving application at application receiving Centre. Candidate will not be allowed to appear in the interview without original Receipt of Token Number.

2. The applicant should bring positively following all **Original Documents** while attending the interview.

- i) Mark sheets/ Certificate for educational qualification ii) SC/ST/OBC certificates, iii) Certificate in co-curriculum field (sports/culture) etc., iv) Citizenship/ PRTC, v) Age proof certificates, vi) Employment Registration card, vii) An affidavit sworn before a Judicial Magistrate or authenticated by a Notary Public to the effect that there is no Govt. service holder in her/his family as a token of evidence, viii) Income certificate from the SDM of his/her domicile Sub-Division.

3. Candidates who do not fulfill the eligibility criterion mentioned in the advertisement against the applied post would not be allowed to appear before the interview board.

4. Candidates who failed to appear in the interview on the scheduled date & time will not be considered for the post.

5. Candidates must bring their original Voter Identity Card/ Aadhar Card as the proof of identity.

6. Mobile phone, e-book reader, i-pad, calculator, Pen etc. would not be allowed to carry by the candidate in the interview.


7. No TA/DA shall be paid for appearing the interview.
