**A self-attested photocopy of all aforementioned documents are required for submission to HR department. You all are required to carry two latest passport size photographs not more than three (03) months old.**

**Candidates working in Govt. organisations /PSUs are required to carry NOC at the interview failing which an undertaking would be taken that such candidates will not be eligible for any transfer benefits/ pay protection in case of selection. (Not applicable for FT posts)**

**If any information furnished by you is found incorrect/false, your candidature will be rejected and you will not be eligible for reimbursement of journey tickets.**

**Outstation candidates would be reimbursed to and fro journey fare upto second AC train fare on production of confirmed tickets. (No fare reimbursement would be given to candidates from NCR region).**
