**Instructions:**

- Shortlisted candidates whose educational score in degree is in CGPA, should submit proof of conversion factor of CGPA to percentage.
- Applicants should bring all the **Original certificates** in Proof of age, community, educational qualifications (degree & marks sheets) and **experience certificates/ letters** while coming for the interview, failing which the interview of the candidate will not be held. **All the documents submitted by the applicants shall be verified from original documents.**
- One of the eligibility condition is experience of **six years**. Therefore, certificate/proof submitted in support of experience should clearly mention the date of joining & relieving. The candidates should bring original certificate of experience issued by their previous employers to verify their experience, photocopy or scan copy shall not be accepted as proof of experience without original documents. **Offer letter will not be considered as proof**, the candidate should submit acceptable proof of joining & relieving.
- Provisionally Eligible candidates (PE) are required to report at 9.30 AM on the date of interview and will be interviewed only on producing/submitting the requisite documents (including those mentioned in remarks column above against each Provisionally Eligible(PE) candidate) and checking thereof. If it is observed that the documents submitted do not substantiate relevant experience, then the candidature may be cancelled.
- Failure to adhere to above may lead to cancellation of the candidature. The interview of such candidates may be held at discretion of IrconISL management. No claim whatsoever in case of cancellation of candidature/non-interview (due to non-adherence as mentioned above) shall be entertained.
