- i. Marksheets/Certificate of completing relevant course [SWA/Hydrographer (PO "Q" SR) /Fire (NBCD (I))] in Indian Navy
- c. 'CANDIDATE'S COPY' portion of Bank Challan.
- d. Experience: **(12 years post qualification experience from the date of passing relevant qualification)**
