1. Documents in original along with one set of self-attested photocopy:

- (i) Identity Proof viz. Aadhar Card/PAN Card/Passport/Driving License etc.
- (ii) Date of Birth Proof – Matriculation Certificate(Class-X)/ Birth Certificate
- (iii) Educational Qualification –
 - (a) All mark-sheets(year-wise/semester-wise) from Matriculation onwards.
 - (b) Degree/Diploma Certificate
- (iv) Proof of norms adopted by the University/Institute to convert CGPA/OGPA/DGPA into percentage.
- (v) Original Relieving letter from Present employer (if presently employed).
- (vi) SC/ST Certificate in the prescribed GOI format from Competent Authority, if applicable.
- (vii) OBC(NCL) Certificate in the prescribed GOI format from Competent Authority, if applicable.
- (viii) OBC(NCL) Declaration form regarding Non-Creamy Layer status in respect of OBC(NCL) candidates in the prescribed format.
- (ix) Disability Certificate in case of PwD candidate in the prescribed format, if applicable.
- (x) Recent Passport size coloured photographs (6 copies).

Note: In case any candidate fails to bring any of the above mentioned certificates/ documents or found to be not eligible (as per eligibility criteria specified in the detailed advertisement No. SR-I/01/2016 dated 01.02.2016), then the candidature shall be summarily rejected and he shall not be allowed to appear in Pre-Employment Medical Test. Hence, shortlisted candidates must ensure their eligibility for the subject post before proceeding for documents verification & pre-employment Medical Test.
