This is to further inform that candidates must present himself/ herself at the time of verification and no third party will be allowed at the time of verification. **No request for change of date and time of verification made by the candidate will be entertained.**

The candidates must bring undernoted documents for verification:

- Photo proof identity card (Passport or Voter ID Card or ADHAR Card or Pan Card).
- Permanent resident Proof of West Bengal (Passport or Voter ID Card or ADHAR Card or Ration Card).
- Age Proof Certificate (Madhyamik or equivalent examination certificate)
- Caste Category Certificate (if any) issued **before 10.1.14**, the last date of submission of on-line application. In case of OBC candidates, category 'A' or 'B' must be mentioned specifically in the caste certificate.
- **Candidates claiming OBC-A or OBC-B shall submit an affidavit in original declaring that he/she is aware of the provision of "West Bengal backward classes (other than Schedule Castes and Schedule Tribes) (Reservation of Vacancies in Services and Posts) Act, 2012 (West Bengal Act XXXIX of 2012) and he/she shall not be excluded from the purview of OBC specified in Column 3 of Schedule II of the West Bengal backward classes (other than Schedule Castes and Schedule Tribes) (Reservation of Vacancies in Services and Posts) Act, 2012 (West Bengal Act XXXIX of 2012)".
