- That the Second Party shall submit himself/herself to the orders of Zilla Parishad and of the
  Officers/Authorities under whom he/she may from time to time be placed by the First Party an
  shall at all times, obey the rules prescribed and shall discharge whenever required to perform suc
  duties as may be assigned.
- 3. That the Second Party shall employ himself/herself efficiently and diligently and to the best of his/her ability.
- 4. That the Second Party shall be paid Rs 5,200/-(Rupees Five thousand two hundred) only per mont as consolidated honorarium.
- That the Second Party shall not claim the service benefits as admissible to the State Government employees.

- That the Second Party shall not be eligible subject to exigency of Public Service for casual leave o
   days during an academic year.
- 8.
