ENGAGEMENT ORDER NO. 1145 / DT. 21/09/2016

Pursuant to Govt. Letter no.20409/SME dtd.11.09.2014 in S&ME Deptt. Govt. of Odisha and Corrigendum Notice No.1297 dtd.09.02.2016 of S.P.D., OPEPA the following selected candidates are hereby engaged as "Sikshya Sahayak" under Koraput District for a period as mentioned in the agreement on a fixed monthly honorarium of Rs.5200/- (Rupees Five Thousand Two Hundred) only subject to the following terms and condition :-

1. Teaching in the school shall be the main duty of the Sikshya Sahayaks.
2. They must maintain regularity and punctuality in attending school.
3. They must ensure completion of entire curriculum within the specified time.
4. They must assess the learning ability of each child and accordingly supplement additional instructions if any as required.
5. They must ensure minimum level of learning (MLL) for the students as prescribed by the Competent Authority (School & Mass Education Department).
6. They must ensure at least 90% attendance of the children in respective schools in all classes.
7. They shall reduce the dropout rate of the children in school below 10%.
8. They shall motivate the parents/guardians of the village in which Primary / Upper Primary School is situated for enrollment of children within the age group of 6 to 14 years. It shall be his/her duty to contact parents/ guardians in case children fail to attend classes regularly and get back such children to the classes.
9. They will hold regular meeting with parents and guardians and apprise them about the regularity in attendance, ability to learn, progress made in learning and any relevant information about the child.
10. They shall perform all such other duties as assigned to them by the competent authority as and when required.
11. They shall abide by the rationalization of teachers policy of Govt. as issued from time to time.
12. Whenever applicable they will work under the administrative control of Head Pandit / Head Master or Head Mistress in charge of the school to which he/she is assigned. They shall perform the duties as will be entrusted upon him/her by the concerned Head Pandit / Head Master or Head Mistress.
13. They may be assigned any other work in furtherance of the objective of the universalisation of Primary Education/RTE Act by Chief Executive Officer, Zilla Parishad, Koraput or any other authority as decided by Government in School & Mass Education Department from time to time.
14. The engagement shall be cancelled, if any fraudulent testimonial is detected in future, if he/she is criminally proceeded against.
