The appointees shall be on probation for a period of two years and shall be allowed to join only on production of the following certificates/documents in original:-

- i. Education Technical Qualification Certificate/marks sheets which will also include whether technical degree/ diploma is approved for employment in J&K.
- ii. Date of Birth Certificate/Qualification Certificate.

- iii. Permanent Resident Certificate/State Subject.
- iv. Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- v. Character and Antecedents Certificate.
- vi. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained/availed by the concerned candidates.
- vii. Reserved Category Certificate, wherever required.
- viii. Any other relevant certificate as required under rules.

Further, the above appointments are provisional and subject to the following conditions:-

- a) The Chief Engineer, PHE Department, Kashmir shall personally verify the genuineness of institution and qualification Certificate/Category Certificate/ Permanent Resident Certificate etc. under rules.
- b) Each appointee shall give an undertaking in the shape of an affidavit that in case any adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, J&K to whom reference shall be made by the authority to whom they shall submit their joining report or any other adverse report about their qualification, the candidate shall have no right to claim his/her appointment as Draftsman (Civil) and his/her appointment as such shall be deemed to be void-ab-initio and cancelled as such.
- c) Salary of these appointees shall not be drawn and disbursed to them unless satisfactory character and antecedents report is received from the ADGP, CID and verification of genuineness of their qualification/ category and any other certificates and it received from the concerned authorities.

Consequent upon their appointment, these candidates shall report to the Chief Engineer, PHE Department, Kashmir for further duties within a period of 21 days from the date of issuance of this order. If any candidate fails to do so, his/her appointment shall be treated as cancelled ab-initio.

The appointment of above mentioned candidates will not come under the purview of new Recruitment Policy notified by the General Administration Department vide SRO-202 of 2015 dated 30.06.2015 and while as the inter-se-seniority of the appointee shall be in order of merit as per the selection list furnished by the J&K SSB.

Further, the selected candidates, who have been appointed under Resident of Backward Area (RBA) category shall be adjusted by the HoD in backward area in terms of Section 3(2) of Jammu and Kashmir Reservation Act, 2004 as amended from time to time.

This order is issued subject to outcome of writ petition(s), if any, pending in any Court of Law of competent jurisdiction.


