On the basis of the recommendation of the Recruitment Committee, the undersigned hereby offer to the Full Time Casual Labourers mentioned in the Annexure-I to this Memorandum, an offer of appointment as Multi Tasking Staff (Public Works) in the Divisions of this Department indicated against them in the Pay Band of Rs.4440-7440/- with Grade Pay of Rs.1,300/- purely on temporary and ad-hoc basis. They will also be entitled to draw the dearness and other allowances at the rates admissible and subject to the conditions laid down in the rules and orders governing the grant of such allowances in force from time to time.

2. The terms of appointment are as follows:-

- (i). The post in which appointed is temporary but is likely to become permanent. In the event of it becoming permanent his/her claims for permanent absorption will be considered in accordance with Rules in force.
- (ii). The appointment is purely on temporary and adhoc basis and may be terminated at any time by a month's notice given by either side without assigning any reason therefor. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- (iii). Other conditions of service will be governed by the relevant rules and orders in force from time to time.

8. The appointment is provisional and is subject to the Caste Certificates being verified through proper channels and if the verification reveals that the claim belong to OBC/MBC/EBC/BCM/BT/SC is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.

9. If the candidate (as per Annexure - I) accepts the offer on the above terms and conditions he/she should communicate his/her acceptance and report for duty before the Executive Engineers concerned (as mentioned in Annexure-I) **on or before 25.07.2016.** If no reply is received or the candidate fails to report for duty within this prescribed date, the offer will be treated as cancelled.

10. No Travelling Allowance will be allowed for joining the post.
