**ORDER**

The Kerala Public Service Commission,Thiruvananthapuram, vide letter read above has advised **19** candidates for appointment to the post of Veterinary Surgeons in the scale of pay of 20,740-36,140 (Pre revised scale).They are appointed temporarily as **Veterinary Surgeon Gr.II on Rs.39,500 – 83,000 (Revised Scale)** at the station noted against their names. The advice of the candidates is subject to Rule 3(C) of the General Rules of KS&SSR of 1958.The appointment is purely provisional under Rule 9(a) (1) of General Rules as provided for in Rule 10(b) of those rules. This provisional appointment will be regularized only after the receipt of the verification report from Police Department and verification report by KPSC authorities and also subject to provisions of G.O (P) No.41/2010/P&ARD dated 14/12/2010 and subsequent Government Orders.

The candidate should report before the District Animal Husbandry Officer (Controlling Officer) concerned with all documents in proof of date of birth, community,qualifications, health and character certificate from Gazetted Officers in original. **The candidate should also produce the original one time verification certificate of Kerala Public Service Commission at the time of reporting for duty. The candidate who fails to produce original one time verification certificate shall not admitted to duty under any circumstances.** Request if any made in future for the correction of date of birth will be entertained only according to the provision in G.O(P) No.45/91/P&ARD dated 30/12/1991.

The controlling officer should admit the candidates after satisfying themselves about the identity of the candidates with reference to their signature

and identification certificates. The identification certificate forwarded herewith should be returned to this office duly noting the certificate of identification and the relevant columns to be filled up.

The candidate shall fill the proforma for verification of the character and antecedents and the same is to be forwarded to this office immediately by the controlling officer duly attesting the photograph and with the certificate (below the declaration of the candidate) SPARK FORM NO: 1 as appended to this order also should be duly filled. The candidate should also submit Medical Fitness certificate issued by a Medical Officer not below the rank of Assistant Surgeon duly affixed his/her recent passport size photograph and thump impression on medical certificate duly attested by the Medical Officer, as prescribed in G.O(P) No.20/2011/P&ARD dated 30/06/2011.

The certificate of transfer of charge in respect of joining duty is to be forwarded to the Accountant General (A&E) Ernakulam and other controlling officers without fail.

The candidate shall join duty within 15 days from the date of receipt of this order, otherwise the advice will be cancelled by the Public Service Commission, unless extension of joining time granted by the competent authority.

The Officers appointed will be on probation for a period of two years duty within a continuous period of three years.
