OFFICE ORDER

The appointment is purely contractual and shall be terminated at any time without assigning any reason thereof.

They shall draw consolidated monthly remuneration equal to the initial of the corresponding pay i.e. Rs.9300-34800/- + Grade Pay Rs.4200/- during the period of contractual appointment.

On the date of satisfactory completion of six years of contractual service they shall be deemed to have been regularly appointed.

They shall not be entitled to D.A., HRA & other allowances during the period of contractual appointment.

They shall abide by the OCS Conduct Rules, 1959 & subject to the OCS (CCA) Rules,1962.

They shall be entitled to leave, under the provisions of the Odisha Leave Rules, 1966 at par with regular employees of Govt. of Odisha.

They should join on or before 22.06.2015 failing which their appointment order shall stand cancelled.
