In pursuance of Advt. No. CSIR-CRRI/ PC /03/JHT /2015 dated 05/09/2015 and corrigendum dated 05/05/2016 regarding advertisement for one post (Unreserved) of Junior Hindi Translator in the Pay Scale of the Pay Band -2(PB-2) i.e. Rs. 9300-34800 with the Grade Pay of Rs. 4200/-, the Director CSIR-Central Road Research Institute has been pleased to approve the following panel **in the order of merit**, who have attained the qualifying marks in both papers (ie 75 marks in paper I and 75 marks in paper II) :-

The offer of appointment will be given only to the first candidate in the order of merit since only one post (Unreserved) of Junior Hindi Translator was advertised vide aforementioned CRRI advertisement. In case, the selected candidate does not join or accept the offer of appointment by the stipulated date or resigns after joining, the offer of appointment can be given to the next candidate in the panel. The panel shall be valid for one year from the date of issue of this notification.

3. The candidate should strictly fulfil all the conditions as specified in the CRRI advertisement no. CSIR-CRRI/PC /03/JHT /2015 dated 05/09/2015 and corrigendum dated 05/05/2016. The appointment and the final selection of the candidate **shall be subject to the production of all the complete original certificates regarding age, educational qualification, experience etc in support of his/her candidature and also subject to among other things thorough verification of his/her identity with reference to his/her photograph, signature, handwriting etc. on the application form, e-admit card etc. The appointment/ selection of the candidate is liable to be cancelled by this office in case candidate doesnot fulfill the eligibility conditions as per the aforesaid CRRI advertisement.**

4. If at any stage, later on, the documents/ information furnished by the candidate in his/her application form is found to be incorrect/ false, the selection of the candidate shall be liable to be terminated even after appointment without prejudice to any other action which may be taken against him/her as deemed fit by the Director, CRRI.

5. The panel of the candidates in the order of merit is being hereby displayed for information in pursuance of Central Vigilance Commission(CVC) Guidelines as communicated vide annexure to the CSIR circular letter no. 6(83)/98-O&M dated 02.02.1999.
