The above selected candidates are hereby instructed to join in the office of the undersigned on or before 01.01.2017. In case any candidate fails to join by the stipulated date, her engagement shall stand cancelled automatically and she will forfeit her claim for engagement in future.

The engagement is subject to the following terms and conditions.

- 1- That the engagement is valid for a period of **One year** commencing from the date of joining till completion of one year i.e 365 days and no formal notice or order is required to be issued by the authority.
- 2- The engagement is purely temporary and terminable at any time without prior notice or assignment any reason thereof. The engagement shall also be terminated with closure of the Scheme.
- 3- The appointing authority reserves the right to terminate in the event of unsatisfactory performance as per job responsibility (copy enclosed in Annexure-A) or under any administrative exigency without assigning any reason thereof.
- 4- That she will obey the instruction of authority and shall discharge such duties under **VCFS programme** as assigned and other related works as required to be performed by her from time to time.
- 5- That she will be paid Rs.4, 000/- (four thousand) only as honorarium per month.
- 6- That she will not be entitled to any other kind of absence beyond authorized leave.
- 7- That she will not claim any of the service benefits before the State Government and her claim will not be entertained by the authority in any manner.
- 8- That she is not eligible to get any other allowances except travel allowance for VCFS & other allowances if any, applicable under VCFS guidelines.
- 9- In the event of any misconduct, she will be liable for immediate disengagement.
- 10- In case she desire to quit the post in the middle of the period, she has to give at least one month notice before leaving.
- 11- She will not work under any other private /government/public sector undertaking during the period of such engagement.
- 12- She can not take part in any political activities while holding of this post.
- 13- The engagement shall be subject to the orders of Hon;ble Court, in case any court case arises regarding your engagement.
- 14- If any certificate submitted by Village Coordinator proved fake/false in future, she will be terminated without any notice.




