ORDER

In pursuance of letter No. 40183/R&DM dated 22.12.2016 of Joint Secretary to Govt. Revenue and Disaster Management Deptt. They shall be on probation for a period of two years.....from the date of their joining in the post. If during or at the end of the aforementioned probation period, they are found unfit to continue further, their service shall be terminated forthwith with assigning any reason thereof.

No TA will be allowed for joining in the post.

They shall be governed under the provisions of New Pension Scheme Amendment Rules 2005.

They shall furnish the following certificates in original at the time of joining in the post in the respective office where they have been posted.

1. High School Certificate for verification of date of birth.
2. Caste Certificate from the Competent Authority.
3. Medical fitness certificate from the authorised medical officer of a Govt. Hospital not below the rank of Assistant Surgeon.
4. If married, declaration to the effect that he/she has not more than one spouse living.
5. Character and antecedent in Form Schedule LIII-88 for verification and two Character certificate from two separate Gazetted Officers.
6. Property statement in sealed cover as required under Odisha Government Servant's Conduct Rules.
7. Oath of allegiance to the constitution of India
