ORDER

In reference to the Memo No: HFW/NUHM-1236/2017/1222 dated 11/07/2017 of the MD (NHM), Govt of WB, Deptt of H&FW & Memo No: DHFWS/HOW/2447/17 dated 25/09/2017 of the above office, the following Staff Nurses for Urban Primary Health Centre (UPHC) of the Urban Local Bodies (ULBs) under National Urban Health Mission (NUHM) are selected from the Waiting Panel by the District Selection Committee, Howrah and they are hereby offered the engagement on contractual basis at a monthly consolidated remuneration of Rs.17,220/- (Rupees seventeen thousand two hundred & twenty only) for an initial period up to 31/03/2018 from the date of joining. The period of contract will automatically be terminated after expiry of 31/03/2018, which may be extended further on the basis of satisfactory performance and need of the programme. The engagement can be terminated by serving one-month notice from either side. Such engagement would not, however, entitle the concerned Staff to any claim of permanent employment under the State Government. If the incumbent proposes to cease her work without covering one month notice period, her remuneration will be deducted accordingly. She is directed to report to the undersigned within 28th February 2018 without fail.
