
The above mentioned candidates are here by engaged as per the terms and condition mentioned below :

- 5) The service may also be terminated by one month's notice from either side.
- 6) Payment of remuneration will be made from the WBSAP&CS Fund.

format (enclosed herewith) issued by the M.B.B.S. practitioners. The CMOH in turn will direct the Laboratory Technicians, Technical Supervisors & Counselors to report to the respective Superintendents (DH/SDH/SGH) who are selected for different Health facilities.

- 8) The Candidate should join within 15 days from the date of issuance of the order.
- 9) Any person failing to report to the designated office within stipulated period , may not be allowed to join later and his/her engagement stands cancelled after that period.


