In pursuance of the decision conveyed by Govt. of H.P. 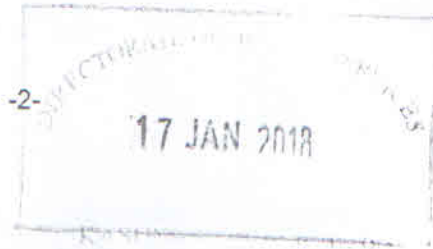
The above mentioned Staff Nurse will submit her joining at her present place of posting on regularization.

The cases of left out Staff Nurses if any will be considered separately & if any discrepancies noticed at any stage must be brought into the notice of this office so that the facts could be rectified accordingly.

The above appointment shall be subject to the following terms and conditions :-

1. The appointment/regularization is purely on temporary and liable to be terminated at any time by a month's notice from either side viz, the appointee or appointing authority.
2. The appointment carries liabilities to serve in anywhere in Himachal Pradesh.
3. The appointment is further subject to the production of following certificates/documents before joining the duty in the respective institution.
 - a) Certificate of Medical Fitness issued by the Chief Medical Officer/Sr. Medical Superintendent of the concerned District.
 - b) Certificate of Educational qualification i.e. Matriculation Certificate/Plus Two/Diploma in GNM duly recognized by the Central/State Govt. and duly registered with HP State Nursing Council Shimla.
 - c) Character certificate from the Magistrate First Class or any Gazetted Officer to whom the candidate is known for the last five years.
 - d) Certificate of Bonafide Resident of Himachal Pradesh.
 - e) A certificate if he/she belongs to SC/ST/OBC/WFF/IRDP from the Magistrate 1st Class.
 - f) A declaration that candidate have not/shall not have more than one living husband/wife.
 - g) A declaration to the effect that if any of the information or documents submitted by him/her is found false, his/her services will be terminated without any further notice.
 - h) The appointee shall have to submit the nomination of Group Insurance Scheme, 1984 at the time of joining of duty.
 - i) That the appointment is subject to the verification of his/her character and antecedents.
 - j) No TA/DA will be allowed for joining the duty.
 - k) If the above terms and conditions are acceptable to him/her, he/she should report for duty at their present place of posting within fifteen days which the offer shall be treated as cancelled.
 - l) The appointee shall have to submit his/her assets and liability on the prescribed proforma within one month after joining.
