ORDER

Consequent upon amendments of cadre rule made vide Notification No. H/MA/51/HCR-Tech/41M-1-90/Part-I dated 15.01.96, the following Grade III Technical Assistants of Group - 'B' of the West Bengal Sub-Ordinate Health Services (NMTP) Cadre now/previously attached to the post noted against each are hereby promoted temporarily from Grade - III to Grade - II of the same group in the scale of pay of Rs. 3800-100-4100-125-4725-150-6375-175-7775/- or in the pay Band 3 i.e. Rs. 7100 - 37600/- with Grade pay Rs. 3200/- as the case may be with effect from the dates mentioned against them on completion of their 10(ten) years continuous and satisfactory service in Grade - III of the same group of the aforesaid cadre according to their seniority in service.

The unreserved vacancies are filled up by keeping the proportionate number of posts reserved for reserved categories of employees as provided in West Bengal (Reservation of Vacancies in service and posts) Act 1976.

On promotion to Grade - II the candidates will be designated as Health Inspector and will continue to perform such duties as may be allotted to them from time to time by authority concerned.

Fixation of their pay arising out of their promotion should be made under existing rules.
