As recommended by the J&K Services Selection Board and approval conveyed by the Administrative Department vide above referred to communications, sanction is hereby accorded to the appointment of Mr. Musaib Ahmad Mantoo S/o Gh. Rasool Mantoo R/o Mohammad Pora Kulgam against the post of Library Assistant, Information Department, State Cadre carrying the Pay Band of Rs. 5200-20200 with Grade pay of Rs. 2400 in the Directorate of Information &PR, Srinagar/Jammu with immediate effect.

The appointee shall report to the Director Information & PR, J&K, Srinagar within a period of 21 days from the date of issuance of this order. In case of failure of the appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on production of the following certificates (in original);

- 1. Academic/Technical qualification certificates.
- 2. Matriculation/date of birth certificate
- 3. Health certificate from the concerned Chief Medical Officer of the District.
- 4. Permanent Resident Certificate issued by the competent authority.
- 5. Certificates from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self-employment scheme has been obtained by the appointee.

The appointment of the candidate shall further be subject to the following conditions:

i. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Director Information & PR, J&K Srinagar, he shall have no right or

claim to his appointment, as such, shall be deemed to have been cancelled abinito;

 Genuineness of the academic qualification/technical and PRC certificates from the concerned issuing authorities shall be verified.

The salary of the appointee shall be drawn and disbursed to him only the satisfactory reports in respect of condition (i) and (ii) above are received in his favour.

If, on verification, the certificates produced by the appointee prove to the fake or forged, his appointment shall stand cancelled/abinitio.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

The appointee shall be on probation for a period of two years in terms of CCA rules 1956.

The appointment of the above candidate shall be subject to the final outcome of writ petition(s) if any, pending in any court of the competent jurisdiction.
