TERMS AND CONDITIONS

The selected candidates should join their duty within 15 days from the date of receipt of the appointment order. If the selected candidates are not reported for duty within 15 days his/ her selection will be automatically cancelled and deemed to have been cancelled. After 15 days no plea or excuses will be considered.

The selection of candidates are subject to production of all original documents. If the Validity Certificate (Sindhutva Pramana Patra) for the candidates selected under categories are found fake, his/her selection will be cancelled without giving any notice.

The selected candidate will be under probationary period for the period of minimum two years. If any selected candidates is found having involved in immoral activities, indulging in corrupt practices, found inefficient or misbehaving or working detrimental to the interest of Judicial Institution then he/she will be discharged from the service without any notice and without any enquiry.

If any documents are found fake/forgery/not genuine, his/her selection will be cancelled without giving any notice.

If any candidate is found involving in Criminal Case upon police verification, his /her selection will be cancelled without giving any notice.

If any candidate is found having given false information in the application or submitted fake documents or has given false information during interview his/her selection will be cancelled without giving any notice.

The seniority of the selected candidates stands as per selection list.

If the selected candidates above stated are not reported for duty within stipulated time, then only the candidates who are in the waiting list will be considered in that respective post under that category only.
