In view of Hon'ble High Court's letter in the reference 8th cited, the undersigned is pleased to pass the following:

ORDER:

This Court submitted a list of selected candidates to the 04 posts of Examiner by direct recruitment as per the Notification issued in the reference first cited to the Hon'ble High Court of Judicature at Hyderabad in the reference 7th cited for approval. The Hon'ble High Court of Judicature at Hyderabad approved 04 selected candidates to the posts of Examiner in the reference 8th cited and directed to issue appointment orders to the approved candidates after verification of their antecedents. This Court sent the Antecedent Forms of the said 04 candidates to the Additional Director General of Police, Intelligence Department, Andhra Pradesh, Hyderabad, in the reference 9th cited, for verification of their character and antecedents. While so, this Court received the antecedent reports in respect of 03 candidates only out of 04 selected candidates on different dates in the reference 10th cited.


Hence, the undersigned is pleased to issue the posting orders to the following 03 selected candidates, whose antecedent reports have been received and the undersigned will issue the posting orders to the remaining 01 selected candidate after receipt of his antecedent report.

However, the seniority of the selected direct recruits shall be fixed in accordance with the list approved by the Hon'ble High Court of Judicature at Hyderabad, in the reference 8th cited, as per the serial number in the said approved list irrespective of their joining to duty as per Rule 21(2) of the A.P. Judicial Ministerial Service Rules, 2003.

A.Munnee Bai, d/o A.Nagoji Rao, resident of H.No.17/17, Near Post Office, Pathikonda – 518 380, Kurnool District, who is selected to the post of Examiner under Notification No.2/2013, dated: 21-11-2013 and approved by the Hon'ble High Court of Judicature at Hyderabad, is temporarily appointed and posted as Examiner, Principal Junior Civil Judge's Court, Dhone, in the existing vacancy.
2. **Sri A.Chandra Sekhar, s/o A.Jayanna, resident of H.No.45/185-40, N.R. Nagar, Kurnool – 518 004, Kurnool District. (Await antecedent report).**
3. Sri K.Subramanyam, s/o K.Dastagiri, resident of H.No.1-43, Upstairs, Pendekanti Nagar, Banaganapalli – 518 124, Kurnool District, who is selected to the post of Examiner under Notification No.2/2013, dated: 21-11-2013 and approved by the Hon'ble High Court of Judicature at Hyderabad, is temporarily appointed and posted as Examiner, Junior Civil Judge's Court, Allagadda, in the existing vacancy.
4. Smt. Y. Sulochana Reddy, d/o Y.Ranga Reddy, resident of Chinthalapalli (Post) Midthur Mandal, Kurnool District. Pin Code – 518 405, who is selected to the post of Examiner under Notification No.2/2013, dated: 21-11-2013 and approved by the Hon'ble High Court of Judicature at Hyderabad, is temporarily appointed and posted as Examiner, Principal District Court, Kurnool, in the existing vacancy.

Note:

1. These Orders shall come into force with immediate effect.
2. The appointees are informed that their appointment is purely temporary and it does not confer any right of probation or reappointment and that they will be ousted from service at any time without notice and without assigning any reason.
3. The appointees are directed to join duty forthwith or **within a period of 30 days** as per Rule 11(a) of the A.P. State and Subordinate Service Rules, 1996.
4. The appointees are directed to produce physical fitness certificate issued by the Medical Officer not below the rank of Civil Surgeon at the time joining duty.
5. **The Judicial Officers concerned under whom the appointee/s join** are requested to verify the original Educational Certificates and other Certificates at the time of joining of the appointees to duty and submit the joining reports along with the Physical Fitness Certificates to the District Court, Kurnool.
6. The seniority of the above direct recruits shall be fixed in accordance with the list approved by the Hon'ble High Court of Judicature at Hyderabad, and as per the above serial number irrespective of their joining to duty as per Rule 21(2) of the A.P. Judicial Ministerial Service Rules, 2003.
