NOTE:-

1. That the appointment is on purely ad-hoc basis and the services shall be liable to be terminated at any time without any notice.
2. The service rendered on ad-hoc basis shall not count towards the benefits of pension or gratuity etc..
3. No one will not be entitled to any TA/DA for joining the post.
4. The services will be governed by Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Services) Rules, 1997 and Punjab Civil Services Rules applicable in Haryana State.
5. The appointment is subject to production of medical Fitness Certificate from the Civil Surgeon, Bhiwani.
6. The appointment of the candidate will be subject to production of a certificate of Character from the school last attended, if any, and similar certificate from two responsible persons not being his/her relatives, who are well acquainted with him/her in his/her private life and are not connected with their school.
7. The candidate shall have to produce an affidavit to the effect that he/she was never convicted for any criminal offence involving moral turpitude and that he/she was never dismissed or removed from service of any State Government or Government of India or of any

public undertaking and also that in case, he/she is married, he/she is not keeping more than one living spouse.

8. That in case the candidate is unmarried, he/she shall have to submit a declaration in terms of Rule 13 A of the Government Employees (Conduct) Rules, 1966, to the effect that he/she will not give or take or abet the giving or taking of dowry or demand directly or indirectly from the parent/guardians of the bride or bride-groom, as the case may be, any dowry.
9. The candidate will have to vacate the post at any time without any notice, in case, the post is abolished or there is no vacancy for any reason.
10. If at any stage, the candidate likes to leave the service, he/she will be required to give one month notice or deposit one month's pay including allowances in lieu of notice.
11. The character and antecedents of the selected candidates have not been verified prior to their induction in service, but in case, subsequently, during verification of the character and antecedents, any adverse fact comes to the notice of this office, the services of that candidate are liable to be terminated forthwith, without any further correspondence.

If the candidate is willing to accept the appointment on the terms and conditions, mentioned above, he/she should report for duty to this office within 10 days from the date the information displayed on the website i.e. 20.10.2015, failing which, it shall be deemed that he/she is not interested to join the post and his/her appointment shall stand cancelled by the competent authority and appointment shall be offered to the next candidate in the list.
