The candidate who is now undergoing Post Graduate Studies should execute a bond in person at the Directorate of Insurance Medical Services within 15 days ,on stamp paper worth Rs.200/- along with the original course certificate. They should execute a bond to the effect that they will report for duty on the expiry of joining time and should serve the Government for a minimum period of five years after completion of course ,failing which an amount of Rs.5 lakhs(Rupees Five Lakhs Only) will have to be remitted to Government.

The candidates should produce all relevant records in proof of date of birth, qualifications, Registration and Medical Fitness Certificate as prescribed in **G.O.(P) No: 20/2011/P&ARD dated, 30.06.2011** obtained from a Medical Officer not below the rank of Assistant Surgeon in Government Service and the original One Time Verification Certificate issued by PSC to Regional Deputy Director concerned, at the time of joining duty .

The Regional Deputy Director should satisfy herself/himself about the identity of each candidate before **he/she** is allowed to join duty. For the purpose, scanned copy of identity certificate produced by the candidate at the time of interview/selective list is enclosed. The signature of the candidate on the photograph and the declaration given below the photograph may be verified and the fact recorded on the scanned copy identification certificate itself and the same may be returned to this office along with RTC. If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith.

The original TCMC Registration and Community Certificate/ Non Creamy Layer Certificates of the candidate should be verified at the time of joining duty.

The candidate advised is directed to report for duty within 15 days from the date of receipt of this order, at the respective station with medical fitness certificate as prescribed in **G.O.(P) No: 20/2011/P&ARD dated, 30.06.2011**. In case of those candidates who fail to join duty within stipulated time ,their appointment will be cancelled and the vacancy will be reported to Kerala Public Service Commission as "Not Joining Duty"

The candidates should fill up the Annexure I form at the time of joining duty.

The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission. For this purpose, the Regional Deputy Director shall forward the Original One Time Verification Certificate , Personal Memorandum, Statement showing the details of prior service ,of the incumbent, as ordered in G.O.(P) No: 20/2011/P&ARD dated, 30.06.2011 ,to this office for onward transmission to the Kerala PSC.

The extension of joining time will not be allowed without valid and specific reason.

In the case of candidates whose community is noted in the appointment order, community certificate from the competent authority should be produced.

If the candidate fails to report for duty in time, the fact should be reported to this office without delay with the identification certificate of the candidate.

The RTC should be forwarded promptly.


