5. Medical Fitness Certificate.
6. Relevant category Certificate, if any

If on verification, the Certificate produced by the appointee is proved fake or forged, the appointment shall be cancelled ab-initio.


The appointee shall be on probation period of 5 years and shall join the concerned office (DDO) within a period of 21 days from the date of issuance of this order failing which his/her appointment shall be deemed to be have been cancelled without any further notice.

The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of character and antecedent report is received from Senior Superintendent of Police, Leh to whom the reference shall be made by this office.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated: 24-12-2009 and Jammu & Kashmir Special Recruitment Rules, 2015 notified vide SRO 202 of 2015 dated: 30 June 2015

The inter-seniority of the appointees shall be determined in the order in which their names appear in this order, which is in accordance with the merit secured by these appointees as per selection list furnished by the LAHD-SSRB, Leh.


