

As recommended by the Leh Autonomous Hill Development Sub-Ordinate Services Recruitment Board, Vide Notification No: 01-LAHD-SSRB of 2017 Dated: 25-02-2017 endorsed vide No: DDE&CCL/LAHD-SSRB/GLT/VLW/MPW/Sel.list/17/2343-65 dated: 25-02-2017 , Sanction is hereby accorded to the appointment of the following candidates as VLW/MPW in the pay scale of 5200-202500 with grade pay of 1900/- against the available post.

The ppointment shall be subject to the following conditions:

1. The appointee shall report to the concerned DDO/BDO within a period of 21 days from the date of issuance of appointment order. In case of failure to join within the stipulated period,his/her appointment shall be deemed to have been cancelled abinito without any further notice:
2. In terms of SRO 202 of 2015 dated: 30.06.2015 further prescribed /notified as:
  - I. Appointment would be on regular basis from the date of appointment.
  - II. A person appointed under these rules shall be initially on probation for a period of five years and after completion of five years his service shall be declared as permanent subject to passing of such tests, or successfully undergoing such training as provided under the Jammu and Kashmir Civil Services (classification,control and Appeal ) Rules , 1956 or as prescribed under the




- relevant recruitment rules governing the post/service to which he has been appointed.
- III. During the period of first five years, the appointee shall be entitled to the minimum of scale of pay along with the grade pay applicable to the post against which he is appointed.
  - IV. Every appointee shall after completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which he is appointed. The persons appointed under these rules shall be entitled to annual increments, Dearness Allowance, House Rent Allowance and City Compensation Allowance after successful completion of their five years service on consolidated salary.
  - V. These appointees shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of their appointment.
  - VI. The seniority of persons appointed under these rules shall reckon from the date of their appointment.
  - VII. The period spent on probation/ consolidated salary shall also reckon for purposes of calculating the qualifying service of these appointees for pension and other benefits provided under rules.
  - VIII. Other conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by him belongs, besides other rules, regulations and orders in vogue in the State Civil Services in general.
  - IX. The appointee shall produce the following documents in original at the time of joining in the Department.
    1. Date of Birth Certificate
    2. Permanent Residence Certificate.
    3. Category Certificate, if any, issued by the competent authority.
    4. Qualification Certificate.
    5. Character Certificate.
    6. No Laon certificate from District Employment & Counselling Centre, Leh and District Industries Centre, Leh.
    7. Medical Certificate.
  - X. Appointment of the above candidate shall also governed by the "New Pension Scheme" as per SRO 400 dated: 24.12.2009
  - XI. If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.
  - XII. The salary of the appointee shall be drawn and disbursed only after the receipt of character certificate and Antecedents verification report from verifying agency.
  - XIII. The appointment of the above candidate shall be subject to the outcome of writ petition (S), if any, pending in any court of the competent jurisdiction.
