Accordingly, in the 1st Phase, the re-examination (On-line Test) for the post of **Deputy Executive Engineer (Civil)** has been conducted on **01.12.2016** & its personal interviews were conducted on **25.03.2017**.

- 2. Taking into consideration the performance reflected in the re-examination (Online Test) & personal interview, number of post advertised, horizontal and social reservation etc., the select and wait list of candidates for the post of **Deputy Executive Engineer (Civil)** is prepared.
- 3. While drawing select list, out of 150 marks obtained in On-Line Test have been converted into 95 marks and out of 25 marks obtained in Personal Interview have been converted into 05 marks. Thus merit list has been drawn out of 100 marks.
- 4. The select / wait list will be valid for the period of 1 year from date of publish.
- 5. The select / wait list does not confer any automatic right of possible employment with the Company.
- 6. The selection of the candidate is purely on provisional basis subject to conforming with the conditions notified in the advertisement. If it is found that any candidate is not fulfilling any of the conditions or he/she has knowingly or willfully furnished incorrect or false particulars / fake certificates or suppressed material information, his/her selection is liable to be cancelled and even if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.
