The Deputy Commissioner Udhampur shall take precaution to ascertain genuineness of the qualification certificates/documents and shall verify the certificates confidentially from the concerned University/Institution/Department before drawing her salary and Deputy Commissioner shall immediately take up the matter with this Office, in case, any certificate of the appointee is found/proved false/fake/forged for further course of action. And if on verification of the certificates produced by the appointee are proved fake and forged, the appointment shall be cancelled ab intio.
- The salary of the appointee shall be drawn and disbursed to the appointee only after receipt of character and antecedents verification report from Inspector General of Police (CID).
