At the time of reporting, the candidates must ensure that they fulfill the eligibility criteria in respect of age, category (SC/ST/OBC/PWD), and educational qualification etc. as stipulated in the advertisement/notification for CWE PO/MT-V by IBPS and produce original testimonials / documents for verification. **Reserved category candidates are required to submit the Caste/PWD certificate as per Govt. of India guidelines (Specimen also available on Bank's Website in the Recruitment section).**

At the time of reporting at **Human Resource Development Institute, Noida** the candidates will have to produce the following documents in original for verification along with a set of self attested photocopies:-

- Educational certificates / testimonials (birth certificate / mark sheets/ pass certificates/ degree certificate PAN Card, Aadhar Card).
- The enclosed application for appointment form duly filled in your own handwriting along with self attested photograph affixed at the appropriate place.
- The enclosed Secrecy & Fidelity Bond duly filled in.
- The enclosed Attestation Form duly filled in with all details therein.



- e. The enclosed Permanent Retirement Account Number (PRAN) duly filled form with all details therein.
- f. Original Scheduled Caste/Scheduled Tribe/Other Backward Class/Disability Certificate along with attested photocopy thereof, for verification, if applicable. For candidates belonging to OBC category, OBC caste certificate containing the Non-creamy layer clause should be valid as per Government Guidelines. Caste Name mentioned in certificate should tally letter by letter with Central Government list / notification and must specify that the candidate *does not belong to Creamy layer* section excluded from the benefits of reservation for OBCs. Please ensure that respective caste certificate is as per the performa prescribed by the Government of India and should have been issued by the competent authority.
- g. If employed, a clean relieving certificate from your present employer stating therein that there is nothing against you.
- h. Medical certificate of your fitness from a Registered Medical Practitioner not below the rank of M.B.B.S. (Format available on Bank's website)
- i. Three additional passport size photographs of your frontal pose duly self attested at the back thereof.
- j. As per government guidelines Aadhar card is mandatory of opening of saving account. Accordingly candidates are advised to bring Copy of Aadhar card & original for verification. Candidates who do not possess Aadhar card are advised to apply for the same on urgent basis as they have to submit as a proof the copy of acknowledgment of Aadhar application.

The Caste/Tribe/Community certificate issued by the following authorities in the prescribed format for SCs/STs/OBCs will only be accepted as proof in support of a candidate's claim as belonging to the Scheduled Caste or Scheduled Tribe or Other Backward Class:

- i. District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- ii. Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- iii. Revenue Officer not below the rank of Tehsildar; and
- iv. Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Those candidates who fail to produce required original documents will not be allowed to join the Bank.

In case it is detected at any stage, either at the time of verification of documents or even after appointment in the Bank, that any candidate does not fulfill the eligibility norms and/or has furnished any incorrect/false information/certificates/documents or



has suppressed any material fact(s), his/her services are liable to be summarily terminated.

The candidates are informed that their candidature may be cancelled in case it is found that they do not satisfy the eligibility criteria stipulated in the notification.
