At the time of reporting at respective Human Resource Development Institutes on **24.04.2017** the candidates will have to produce the following documents in original for verification along with a set of self attested photocopies:-

- Educational certificates / testimonials (birth certificate / mark sheets/ pass certificates/ degree certificate PAN Card, Aadhar Card etc.)
- The enclosed Application for Appointment Form duly filled in your own handwriting along with self attested photograph affixed at the appropriate place.
- The enclosed Secrecy & Fidelity Bond duly filled in.
- The enclosed Attestation Form duly filled in with all details therein.
- The enclosed Permanent Retirement Account Number (PRAN) duly filled form with all details therein.
- Original Scheduled Caste/Scheduled Tribe/Other Backward Class/Disability Certificate along with attested photocopy thereof, for verification, if applicable. For candidates belonging to OBC category, OBC caste certificate containing the Non-creamy layer clause should be valid as per Government Guidelines. Caste Name mentioned in certificate should tally letter by letter with Central Government list / notification and must specify that the candidate *does not belong to Creamy layer* section excluded from the benefits of reservation for OBCs. Please ensure that respective caste certificate is as per the performa prescribed by the Government of India and should have been issued by the competent authority.
