At the time of reporting the candidates must ensure that they fulfill the eligibility criteria in respect of age, category (SC/ST/OBC/PWD), educational qualification, etc. as stipulated in the advertisement/notification for CWE CLERK -III by IBPS, and produce original testimonials / documents for verification. **Reserved category candidates are required to submit the Caste/PWD certificate as per Govt. of India (Specimen also available on Bank's Website in the Recruitment section).**

At the time of reporting at **Human Resources Development Institute, Noida on 18.05.2015**, the candidates will have to produce the following documents in original for verification along with a set of self attested photocopies:-

- Educational certificates / testimonials (birth certificate / marksheets/ pass certificates/ degree certificate etc.).
- The enclosed Employment Form duly filled in your own handwriting along with three self attested photograph affixed at the appropriate place.
- Original Scheduled Caste/Scheduled Tribe/Other Backward Class/Disability Certificate along with attested photocopy thereof, for verification, if applicable. For candidates belonging to OBC category, the certificate must be of recent date and must specify that the candidate *does not belong to Creamy layer* section excluded from the benefits of reservation for OBCs.

- d. If employed, a clean relieving certificate from your present employer stating therein that there is nothing against you.
- e. Medical certificate of your fitness from a Registered Medical Practitioner not below M.B.B.S.
- f. The enclosed Secrecy & Fidelity Bond duly filled in.
- g. Three additional passport size photographs of your frontal pose duly self attested at the back thereof.
- h. The enclosed Attestation Form duly filled in with all details therein.

The Caste/Tribe/Community certificate issued by the following authorities in the prescribed form for SCs/STs and for OBCs will only be accepted as proof in support of a candidate's claim as belonging to the Scheduled Caste or the Scheduled Tribe or the Other Backward Class:

- (i) District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendary Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- (iii) Revenue Officer not below the rank of Tehsildar; and
- (iv) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Those candidates who fail to produce required original documents will not be allowed to join the Bank.

In case In case it is detected at any stage, even after appointment in the Bank, that any candidate does not fulfill the eligibility norms and/or has furnished any incorrect/false information/certificates/documents or has suppressed any material fact(s), his/her services are liable to be summarily terminated.
