At the time of reporting the candidates must ensure that they fulfill the eligibility criteria in respect of age, category (SC/ST/OBC/PWD), educational qualification, etc. as stipulated in the advertisement/notification for CWE- SPL-III by IBPS, and produce original testimonials / documents for verification. **Reserved category candidates are required to submit the Caste/PWD certificate as per Govt. of India.**

The Caste/Tribe/Community certificate issued by the following authorities in the prescribed form for SCs/STs and for OBCs will only be accepted as proof in support of a candidate's claim as belonging to the Scheduled Caste or the Scheduled Tribe or the Other Backward Class:

- (i) District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendary Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- (iii) Revenue Officer not below the rank of Tehsildar; and

(iv) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Also OBC Caste Certificate should be of recent date and must specify that the candidate *does not belong to Creamy layer* section excluded from the benefits of reservation for OBCs. Those candidates who fail to submit required original documents will not be allowed to join the Bank.

The candidates are informed that their candidature may be cancelled in case it is found that they do not satisfy the eligibility criteria stipulated in the notification.
