In pursuance of the proceedings of the Selection Committee meeting held on 26.07.2016, the following 91 selected candidates are hereby engaged as **Physical Education Instructor** in Upper Primary Schools noted against each with the following terms and conditions:

- i. The engagement of the Part Time Instructor is purely temporary in nature and can be terminated at any time without assigning any reason thereof.
- ii. The term of engagement will be for 06 months and can be extended further on half yearly basis on satisfactory performance of duty which be evaluated by the DPC, RTE-SSA, Ganjam and BEO concerned.
- iii. If the performance of the Instructor found unsatisfactory, his engagement will not be extended.
- iv. If the Instructor remains absent continuously for more than 10 classes, he will be disengaged immediately.
- v. The Headmaster of concerned school shall give certificate about the actual no. of classes taken by the instructor which will be countersigned by the BEO concerned before drawl of his remuneration.
- vi. The Instructor will get remuneration @ Rs 150/- (Hundred Fifty Rupees) only per class maximum up to 24 classes in a month.
- vii. OPEPA Service Rules and Regulations, 1996 shall not be applicable for the engagement of Instructor.

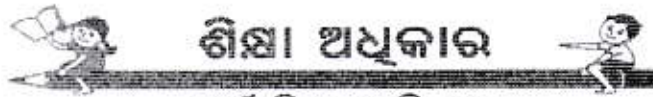

In pursuance of the proceedings of the Selection Committee meeting held on 26.07.2016, the following 24 (23-Visual Art and 01-Performing Art) selected candidates are hereby engaged as **Art Education Instructor** in Upper Primary Schools noted against each with the following terms and conditions:

- i. The engagement of the Part Time Instructor is purely temporary in nature and can be terminated at any time without assigning any reason thereof.
- ii. The term of engagement will be for 06 months and can be extended further on half yearly basis on satisfactory performance of duty which be evaluated by the DPC, RTE-SSA, Ganjam and BEO concerned.
- iii. If the performance of the Instructor found unsatisfactory, his engagement will not be extended.
- iv. If the Instructor remains absent continuously for more than 10 classes, he will be disengaged immediately.
- v. The Headmaster of concerned school shall give certificate about the actual no. of classes taken by the instructor which will be countersigned by the BEO concerned before drawl of his remuneration.
- vi. The Instructor will get remuneration @ Rs 150/- (Hundred Fifty Rupees) only per class maximum up to 24 classes in a month.
- vii. OPEPA Service Rules and Regulations, 1996 shall not be applicable for the engagement of Instructor.
- viii. The Instructor shall submit an undertaking as per prescribed model form that he shall not claim regular scale of pay and other allowances for continuing in the post merely on the ground that he has given a part time engagement and he is fully aware of the terms of engagement.
- ix. He will submit Contract of Engagement (TOR) duly filled in before the District Project Coordinator/BEO concerned on his behalf in the prescribed model form.

- x. He will join at the school on or before **12.08.2016** positively, failing which the engagement order will be treated as cancelled automatically.


