3. Six posts are lying vacant under TG Arts category.
4. The selected candidates whose names are available in the provisional merit list have to remain present personally at District Project Office, SSA, Kendrapara at 3.00 PM on 13.10.2015 positively for original certificate verification.
5. The counseling for the place of posting will be held at 3.30 PM i.e. just after original certificate verification on the same day.
6. The candidate is to bring with them all original certificates along with OTET pass original certificates.
7. The date of issue of engagement order will be notified during counseling.
8. The candidate is to submit medical fitness certificate from any govt. medical as per the prescribed format at the time of receipt of engagement order.
