ORDER:

In the reference cited above, the TSGENCO, in exercise of the power conferred under Regulation 41 of APSEB Service Regulations Part-I has relaxed Clause (ii) (1) relating to the requirement of filling up of 10% of the vacancies of Asst. Engineers by Graduate Sub-Engineers whenever direct recruitment takes place as provided under column (2) against item "Category - 2 Asst. Engineers under Column (1) of Annexure-I referred to in Regulations 6(a) of Part-III of the said Service Regulations as amended in B.P.(P&G-Per) MS.No.354, dt:12.12.1994 to fill up vacancies of Assistant Engineer in TSGENCO by the existing Graduate Sub-Engineer with 4 years service as Asst. Engineer through appointment by transfer on one time basis. Accordingly the following appointment is issued.

2) Under Regulation 14(a)(1) of APSEB Service Regulations Part-II, as adopted, the Chairman & Managing Director/TSGENCO, after careful consideration, hereby appoints **33 (Thirty Three)** Graduate Sub-Engineers mentioned in the Annexure appended to this order by transfer purely on temporary basis as Asst. Engineers (Electrical/Mechanical/Electronics) with effect from the date of their actual joining to duty in the scale of pay of Rs. 41155-1700-44555-1985-54480-2280-63600 with usual allowances admissible from time to time. Their appointments as ordered above shall be subject to the following conditions, namely:-

- i) They are not entitled for any service weightage;
- ii) They have to take last rank of junior most Assistant Engineers appointed vide Notice dated:05.10.2017 against the Notification No. 02/CGM(ADM.IS&ERP)/2015, dt: 23.09.2015.
- iii) The appointment ordered above is purely temporary and liable for termination at any time without notice and without assigning any reasons therefore;
- iv) The appointments ordered above are subject to production of physical fitness certificate issued by a Medical Officer of a rank not less than that of a Civil Surgeon at the time of joining as Asst. Engineer (Electrical/Mechanical/Electronics);
- v) They have to pass the prescribed test(s) as per APSEB Service Regulations as adopted;

- vi) They shall assume charge as Asst. Engineer (Electrical/Mechanical/Electronics) after verification of original certificates by the controlling officers; and
- vii) They shall report to the officer under whose control they are posted within 15 days from the date of relief at the present place of working, failing which their appointment order as Asst. Engineer will be cancelled without further notice;
- 3) The promotions ordered in para-2 above are liable to be reviewed based on the outcome of:-
 - a) The Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.Nos.2360-91/1983;
 - b) W.P.No.1597 of 2010 pending before the Hon'ble High Court of A.P.;
 - c) Subject to outcome of the judgment to be delivered in W.P.No.16330/2015 and batch.
- 4) The Graduate Sub-Engineers on appointment by transfer as Asst. Engineers ordered above are posted to the places noted against their names in the Annexure appended to this order.
- 5) They are requested to assume charge accordingly after obtaining proper relief from the concerned controlling officer, at the places of posting herein ordered.
- 6) The Chief Engineers/Superintending Engineers are requested to issue reposting orders to the candidates allotted to them against the existing vacancies.
