- 2. The "Management Trainees/Student Trainees" engaging on contract basis is subject to the following terms and conditions:-
 - The engagement shall be for a period of One Year only from the date of their joining to duty at the place of posting.
 - ii) The engagement on contract basis shall be terminated with one month notice on either side.
 - iii) They shall be paid an amount of Rs. 20,000/- (Rupees Twenty Thousand only) per month as stipend, subject to the following conditions, namely:-
 - (a) They shall submit the service bond for the period of One year, and
 - (b) They shall pay liquidated damages equivalent to total stipend received by the trainee in case of leaving the service in less than six months service, and 3 months stipend in case of leaving the service after serving more than 6 months service;

- iv) They are not eligible for any other allowances;
- v) They shall produce original Certificates of Age i.e., SSC, Educational certificates along with mark list. Caste certificate issued by the Revenue Officer not below the rank of M.R.O., latest by 6 months, Certificate of Residence/School Study Certificates (from IVth to Xth class), Experience certificates at the time of joining at the place of posting mentioned above; and
- vi) They shall submit an undertaking to the controlling officers—stating that their engagement as Management Trainee/Student Trainee is only on contract basis, and they shall not claim any rights for absorption in TSGENCO at any time.
- 3. The Management Trainees/Student Trainees engaged in para -1 above on contract basis shall report for duty on or before <u>31-01-2017</u> to the concerned officers, failing which the above orders are liable for cancellation without any further notice. No correspondence whatsoever shall be entertained in the matter.
