ORDER

Sub: Appointment to the post of Mechanic
in V.O.Chidambaranar Port Trust - Reg.

Shri V. Selvam is appointed as Mechanic against the post of Mechanic on regular basis in V.O.Chidambaranar Port Trust, in the scale of pay of Rs.16300 – 38200. He will be eligible for the usual allowances admissible under the Rules and Regulations and orders in force from time to time.

2. The terms and conditions of appointment are as follows:-

- i) The appointment is temporary but is likely to continue indefinitely.
- ii) He will be on probation for a period of two years from the date on which he joins duty.
- iii) He will be governed under the Defined Contribution Pension Scheme implemented in V.O.Chidambaranar Port Trust w.e.f 01.01.2004 and the existing system of Defined Contribution Pension and GPF applicable to employees appointed prior to 01.01.2004 will not be available to him.
- iv) Other conditions of service will be governed by the relevant rules in force from time to time.

The appointment will be further subject to:-

- i) Production of Certificate of fitness from the competent Medical Authority, viz., Chief Medical Officer of the V.O.Chidambaranar Port Trust Hospital.
- ii) Submission of declaration in the form enclosed (annexure) to the effect that he does not have more than one spouse living.
- iii) Taking of an oath of allegiance to the constitution of India or making of a solemn affirmation to that effect in the form appended (Annexure II).
- iv) The appointment will be further subject to the production of :-
 - a) Certificate of educational and other qualification ;
 - b) Certificate of age
 - c) Discharge/release certificate from the present employer, if any,
 - d) Attestation form in quadruplicate
 - e) Certificate of communal status
 - f) Character certificate from two serving Gazetted officers of the Central/State Govt. of Stipendary Magistrate in the form appended (Annexure III). The certificate not being more than three months old.

3. He is further informed that if he belongs to Schedule Caste/Schedule Tribe or other Backward Classes he should also produce a certificate in the prescribed form issued by the prescribed authority in support of the claim of belonging to Schedule Caste/Scheduled Tribe or other Backward Classes, vide Appendix 14 and 15 of the Brochures on reservation for Schedule Caste/Schedule Tribe in service and in respect of other Backward Classes vide Department of Personnel & Training O.M.No.360102/22/93-Est.(SCT) dated 15.11.1993, respectively as and when directed by the competent authority during verification of his claim of Schedule Caste/Scheduled Tribe or other Backward Classes.


4. Any change of his religion, change in the submission of his declaration of the marital status should be intimate to the competent authority immediately.

5. If any declaration given or information furnished by the candidate proves to be false or the candidate is found to have willfully suppressed any material information, he will be liable to be removed from service and such other action as the Port may deem necessary.

6. No travelling allowance will be allowed for joining service.

7. He should report for duty to the Chief Mechanical Engineer V.O.Chidambaranar Port Trust on or before **05.12.2015**.
