**Terms & Conditions:**

01. The appointment will be on contract basis initially for one year, which may be extended on year to year basis.
02. The incumbents will be paid fixed contractual amount @ Rs. 7810/-P.M. (which shall be equal to minimum of the pay band + Grade pay). They will be entitled for increase in contractual amount @ Rs. 240 (3% of minimum of the pay band + grade pay of the post) for further extended years and no other benefits such as senior/selection scales etc. will be given
03. The services of the appointee's will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
04. The incumbents will be entitled for one day's casual leave after putting one month service. In addition he will also be entitled for 10 days Medical leave. He shall not be entitled for Medical Re-imburement and LTC etc. No leave of any other kind except above is admissible to them. Unavailed casual leave and Medical leave can be accumulated up to the calendar year and will not be carried forward for the next calendar year.

05. Unauthorized absence from duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. He shall not be entitled for contractual amount for the period of absence from duty.
06. The appointment carries with it the liability to serve any part of Himachal Pradesh under the department of Ayurveda.
07. He will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable to regular counterpart officials at the minimum of pay band.
08. Service Rules like FR, SR, Leave Rules, GPF Rules, Pension & conduct Rules etc. as are applicable in case of regular employees will not be applicable.

**The appointment will be further subject to the production of the following certificates/declaration:**

- i) Attested copies of educational qualification certificates.
- ii) Bonafide Himachal certificate/caste certificate from the competent authority.
- iii) Certificate of fitness from Medical Board of the concerned District Hospitals.
- iv) Taking an oath of allegiance/faithfulness to the constitution of India or making a solemn affirmation to that effect.
- v) Declaration to the effect that the candidate shall not have more than one living spouse.

No TA/DA will be admissible for joining the post.

If above terms and conditions are acceptable to them ,they should report for duty to the concerned offices before 28.09.2012 , failing which it will be presumed that they not interested in the post and offer shall be deemed cancelled.
