4. The appointment is purely temporary & can be terminated at any time without assigning any reason thereof.
5. The appointment is subject to production of Original documents as indicated below .
 - (i) Original HSC Certificate for proof of Age.
 - (ii) Medical certificate in support of his/her physical fitness from a Medical Officer not below the rank of an Assistant Surgeon of a Government Hospital.
 - (iii) Original Certificate in support of higher qualification.


